This unique event celebrates the dawn of motoring in one of Italy's most evocative settings. As spring lights up the colors of the Maremma Livornese, between Bolgheri and Castagneto Carducci, we pay homage to the horseless carriages that changed human mobility. Those were called automobiles until Gabriele D'Annunzio proclaimed: "The automobile is feminine. This one has the grace, the slenderness, the vivacity of a seductress..." Arrival Friday, May 1st after 4:00 PM, registration and welcome. At 7:00 PM, a conference hosted by the Culture Commission of the Italian Historic Automobile Club. On Saturday, May 2nd, we'll take a scenic route along the roads of the Bolgheri DOC, connecting the hills to the cypress-lined avenue that Carducci made famous, passing through the rows of vines that give life to his famous wines. Our itinerary will stop at a prestigious winery, where Tuscan hospitality will blend with the Belle Époque style of our cars. Time will seem to stand still. We'll let the revving of the engines and the scents of the countryside dictate the pace, between exhibitions in the Bolgheri square and exclusive open-air tastings. We'll stay at the Hotel Campastrello Sport in Castagneto Carducci. Nestled in a five-hectare private park, this property will be the perfect retreat for our mechanical jewels and where we can relax between excursions, enjoying the tranquility of this place. On Sunday morning, we'll visit the Maremma Botanical Garden.

INFORMATION ON THE PROCESSING OF PERSONAL DATA pursuant to EU Regulation 2016/67

This is to inform you that your personal data will be processed by Garage del Tempo, a club affiliated with the ASI (Automotoclub Storico Italiano), in full compliance with European Regulation 2016/679.

- Nature of personal data The personal data processed is as follows:
- Name, surname, date and place of birth, residential address (other address if applicable), telephone number, email address, and tax code provided by you in the membership application;
- Data relating to the vehicles for which you request registration in the appropriate registers. The data subjects are club members who apply for membership with Garage del Tempo and the ASI, and natural persons associated with legal entities (e.g., legal representative of a company requesting registration). Please note that providing your data is mandatory, as refusal to provide your data will prevent us from following up on the related event.
- Lawfulness of processing The processing of your personal data is necessary for the legitimate interests of Garage del Tempo and ASI, which guarantee that such interests do not prevail over the interests, rights, and fundamental freedoms of the member.
- Purpose of processing The personal data collected will be processed and used directly to fulfill one or more of the following purposes:
 - Any memberships with Garage del Tempo and ASI;
 - Registration of vehicles in the ASI historical register;
 - Registration for competitions or events;
- Follow up, with reference to the processing of the request and the fulfillment of administrative, accounting, and tax obligations, including legal, related to membership and vehicle registration;
- Organize and promote events organized by Garage del Tempo or in which Garage del Tempo participates, as well as disseminate news and images related to such events, both directly (publications and media managed by Garage del Tempo) and through press releases.
- manage correspondence, communications, and service reports with you. The Joint Data Controllers, for the purposes described above, are:

 - Automotoclub Storico Italiano (A.S.I.), with headquarters in Villa Rey – Strada Val San Martino Superiore, 27, 10131 Turin;
- Scope of communication and dissemination of data Your personal data will not be disclosed, sold, or transferred to third parties. Your data may be disclosed to persons authorized by Garage del Tempo and A.S.I. to carry out activities functional to the organization and when this is essential to fulfill the obligations undertaken by the parties. In this case, use by third parties will be in full compliance with the principle of fairness and legal provisions.

- Garage del Tempo employees authorized to process personal data, as part of their respective duties;

- Rights of the interested party: We inform you that you may exercise your rights (pursuant to Articles 15, 16, 17, and 21 of the Regulation) by contacting the Garage del Tempo headquarters. You have the right to:

 - request restriction of processing;
 - obtain data portability where applicable;
 - also have the right to lodge a complaint with a supervisory authority.
- Data retention If you wish to terminate your relationship with Garage del Tempo and A.S.I. before the natural expiration of your membership or if you fail to renew it, your personal data and the vehicle's data will be retained in our historical archive for 10 years, after which they will be deleted by both Garage del Tempo and A.S.I.

RELEASE FROM CRIMINAL AND CIVIL LIABILITY

All applicable regulations remain in effect, including those regarding traffic on public roads and/or private property, as well as the full application of Italian law, including those regarding civil or criminal liability, for any act or fact that may occur during the event. Each participant is required to comply with the regulations governing road traffic, and failure to comply with them, even if verified and sanctioned by the competent authorities, cannot in any way be attributed to the Garage del Tempo Association and/or any natural or legal person involved in organizing the event.
- 3) The undersigned acknowledges and agrees that Il Garage del Tempo and/or all natural and legal persons involved in organizing the event cannot be held responsible in any way for any theft, robbery, or vandalism to the vehicle and/or luggage or any other property stored therein.
